Are you ready for the changes ahead?

Major changes will be made to the way concessionary fare schemes are managed in England starting in April 2011. Responsibility for concessionary fares across much of the country will pass from district councils to county councils. At the same time new methods will be introduced for calculating reimbursement payments to bus operators. Further change could result from revised funding formulae, and the outcome of the Comprehensive Spending Review.

The timescales on which local authorities responsible for managing concessionary fare schemes must decide on new arrangements is tight. They must publish draft proposals in early December, using new quidance from DfT which was issued for consultation in September. For some county councils, this will be completely new territory. For unitary authorities and PTEs, it will mean applying new reimbursement methods, and potentially managing the practical and political consequences of changed levels of payments to operators.

This provides the setting for Local Transport Today's Third Concessionary Fares conference on 4 November. It will give a platform for the Department for Transport to explain the new administrative arrangements and its revised guidance, and offer practitioners the opportunity to debate the practical implications. It will also look ahead to future developments in this area.
